This water-based cleaner contains natural solvents, chelating agents, and biodegradable surfactants for the fast, safe removal of ink, coffee, graphite, greases, and oils on all surfaces, including most clothing.

Unlike harsh caustics and volatile solvents, *Extra-Strength Cleaner* cleans safely without hazardous fumes and toxic by-products. It is ideal for use in food service areas, garages, and machine shops.

*Extra-Strength Cleaner* is non-toxic and biodegradable.

#### Directions

Empty contents of an *Extra-Strength Cleaner* pack into warm water (see dilutions ratios below). Apply with sponge, cloth, or trigger sprayer. Wipe away with damp cloth.

#### Dilutions

**ST-732 & ST-1372** 

Mix each pack with 1 quart of water for all-purpose spray-and-wipe cleaning. Mix with 2 gallons of water for scrubbing or 4 gallons for damp mopping.

**ST-724** 

Mix each pack with 4 gallons of water for scrubbing or damp mopping. Mix with 1 quart of water for heavy-duty spray-and-wipe cleaning.

**ST-748 QUIK TANK**

Add one 10-ounce pack per 5 gallons of water into Quik Tank container for all-purpose spray-and-wipe cleaning, or two 10-ounce packs per 5 gallons of water for heavy-duty degreasing.
