

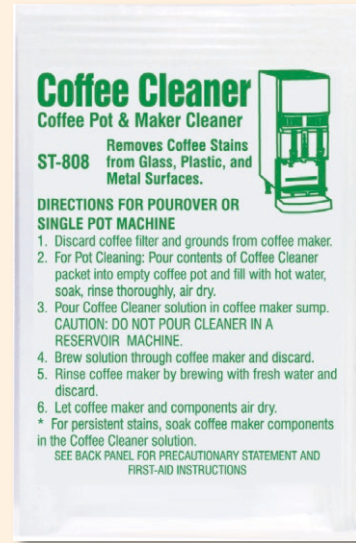

DIRECTIONS FOR POUROVER OR SINGLE POT MACHINE

1. Discard coffee filter and grounds from coffee maker.
 2. For Pot Cleaning: Pour contents of Coffee Cleaner packet into empty coffee pot and fill with hot water, soak, rinse thoroughly, air dry.
 3. Pour Coffee Cleaner solution in coffee maker sump. CAUTION: DO NOT POUR CLEANER IN A RESERVOIR MACHINE.
 4. Brew solution through coffee maker and discard.
 5. Rinse coffee maker by brewing with fresh water and discard.
 6. Let coffee maker and components air dry.
- * For persistent stains, soak coffee maker components in the Coffee Cleaner solution.
